Narrative

AT ABOUT 20:04HRS THE EVENING OF 12/15/2025 I RECIEVED A CALL FROM UNDERSHERIFF ROEHR INSTRUCTING ME TO ASSIST AT THE COUNTY COMMISSIONER MEETING. HE TELLS ME HE DIDNT KNOW WHAT WAS GOING ON BUT SAID IF I COULD GET THERE SOON.

I ARRIVE TO THE COUNTY ASSISTANT WHO TELLS ME THERE WAS AN ISSUE AND THAT THE TWO INVOLVED ARE IN A MEETING INSIDE OF THE BACK OFFICE. I STEP INTO THE OFFICE AND SEE ALL THE COMMISSIONERS IN AN EXECUTIVE MEETING ALONG WITH APRIL WARDEN. AFTER INFORMING THEM I NEEDED TO SPEAK TO THE VICTIM SHE STEPS OUTSIDE WITH ME. PRESEPHONI FULLER TELLS ME TODD STANTON GOT INTO HER FACE POINTING HIS FINGER AT HER. SHE EXPRESSES HOW AFRIAD SHE WAS ...

I ASKED IF SHE WAS OKAY TO RETURN TO THE MEETING, I ASSURED HER I WOULD BE OUTSIDE THE DOOR.

PRESEPHONI WAS SURE SHE WANTED TO PRESS CHARGES FOR ASSAULT ON FULLER.

AFTER THE COMMISSIONER MEETING, PRESEPHONI CHANGED HER MIND AND ASKED ME TO SPEAK WITH STANTON ABOUT SPEAKING TO WOMEN THE WAY HE DID.

SHERIFF WARD SPOKE WITH COMMISSISIONER STANTON, HE THEN INFORMS HIM HE WOULD NOT BE CHARGED WITH ANYTHING. DURING THIS CONVERSATION WITH SHERIFF WARD, COMMISSIONER STANTON ADMITTED TO TELLING PRESEPHONI "WATCH YOUR MOUTH," WHILE HOLDING HIS FINGER UP TO THE LEVEL HER FACE WOULD BE. SHERIFF WARD IN SHORT WORDS TELLS STANTON HE COULD NOT SPEAK THAT WAY.

THERE WERE NO OTHER ISSUES SEEN.
